

General Terms and Conditions of Events

The terms and conditions only apply to events where a company of the BEGO-group (BEGO GmbH & Co.KG, BEGO Bremer Goldschlägerei Wilh. Herbst GmbH & Co. KG, BEGO Implant Systems GmbH & Co. KG and BEGO Medical GmbH) – hereinafter “BEGO”- is the organiser. In the case of course and event offers of our partners the general terms and conditions of business of the partner companies (organisers) apply. The event terms and conditions apply to consumers and entrepreneurs within the meaning of sections 13, 14 of the German Civil Code (BGB). Opposing terms and conditions of the participant will not be recognized.

1. Enrolment

Registration for the event may be by the communicated notification channel. We are entitled to accept your application within 14 days. You will always receive a registration confirmation in written with the inclusion of these Terms of Business. The Agreement only comes about through registration confirmation. Registrations will be considered on a first-come, first-served basis.

2. Attendance fee

Unless otherwise agreed, the attendance fees shall be due and payable immediately after invoice receipt. All event fees within Germany are exclusive of the statutory value added tax and are not discountable.

3. Cancellations

I herewith confirm the reservation of the above mentioned accommodations/dinner participations. Without the booking confirmation and the paid invoice, the cabin is only reserved as non-binding. In case of cancellations until December 13th, 2026 a fee of 50 % per night per cabin will be charged. For cancellations after this date 100 % of the total accommodation fee will be charged. Should you have any special requests for the processing of your invoice, kindly let us know when returning your registration form. We will charge € 50,- incl. VAT for the rewriting of invoices. Prices are based on the current tariffs of the service provider. All prices include breakfast as well as at time of the booking VAT and if necessary additional applicable taxes. You will find this amount separately on your invoice. Invoices need to be paid immediately up to the given date. Within five working days, after maturity date without admonition, you will get in default if the bill was not paid. The resale is not allowed. All prices and details are subject to changes beyond our control.

4. Cancellation of the event and changes to the terms and conditions for the event The event may be cancelled for good cause, for example if there are too few participants, if a lecturer cancels or falls ill or in case of force majeure. Participants are not entitled to claim compensation. We reserve the right to change lecturers or make changes to the course dates and/or the venues.

5. Data protection

BEGO shall undertake to exercise discretion and to handle your personal data in confidence. BEGO employees are required to maintain secrecy and to observe the applicable data protection provisions.

We process personal data on the basis of the European General Data Protection Regulation (GDPR) and the German Federal Data Protection Act (BDSG).

If we process data for purposes other than for those for which the data were collected or if there is no legal basis for permitting the processing, we shall process personal data on the basis of your declaration of consent that we shall obtain from you, as applicable, prior to processing. The consent shall be revocable at any time for the future.

The full information pursuant to the obligation arising from Art. 13, Art. 14 GDPR with details of the nature and purpose of the data to be collected as well as potential recipients, the legal basis and your rights as the data subject is an integral part of this Agreement.
